The MoU may be amended or extended by written consent of the two parties.

2. Both institutions agree and shall endeavor to promote collaborative activities in academic areas of mutual interest on a basis of equality and reciprocity, which shall include but not be limited to the following:

- a) Exchange of academic information
- b) Promoting other academic cooperation as mutually agreed
- c) Conducting lectures and organizing symposia

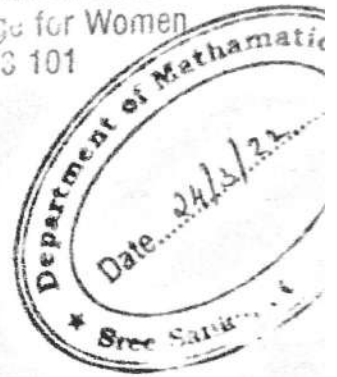
