Memorandum of Understanding



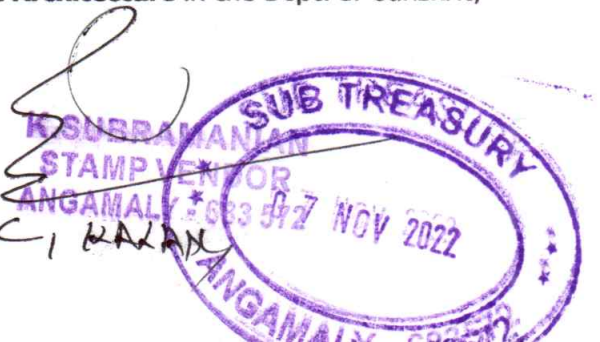
WHEREAS, the Parties desire to memorialise certain terms and conditions of their anticipated endeavour

a. Sree Sankara College Kalady


